President's Message – Sharon L. standing in for Carole P. (because I have internet service!)

Well, this has been a trying time for sure for so many members of our community! Power went out at 5:44 p.m. on Saturday and hasn't yet come back on. A second red flag wind event occurred yesterday into this morning, further pushing back any hope of getting power back soon. Even though we have no evacuations or even smoky skies, we are feeling the effects of no traffic lights, few gas stations, few restaurants and few supermarkets open. Those of us in Mendocino Village know there is a crisis on the coast when the gas station at Schlaffer's – which normally charges in the high \$5 range for gas – has a line of cars waiting to fill up! I'm told the wait at the Chevron in Fort Bragg on Monday (the only station that was open – although today there were at least 4 stations open) was 4 hours long. Patience is certainly an important quality.

But we count our blessings. We are safe. Our hearts go out to the communities that have had to evacuate, to the families that have lost their homes and their belongings. We will be contacting our quilting colleagues in the affected areas of Northern California to offer quilts to help provide comfort.

And, we will be working to improve our ways of keeping in touch with our own members. With many having no internet access, spotty (if any) cell reception, and in some cases no landline service, we need to think about ways in which we can check in with each other to make sure everyone is safe and sound. If you have ideas, please share them!
