Amended bylaws as approved at the September General
Meeting.**

By-laws of the Ocean Wave Quilters, Inc. - February 2001 Amended September 7, 2010,
Amended August 10, 2014, Amended April 10, 2016, Amended June 13, 2016, Amended
September 12, 2021

ARTICLE 1: NAME The name of the organization shall be Ocean Wave Quilters, Inc.

ARTICLE 2: PURPOSE The purpose of this organization shall be: to promote the knowledge of quilting, quilting skills and techniques; to provide an atmosphere of friendship and growth through quilting; to share our enjoyment of quilting through charitable contributions of quilts and through quilt shows.

ARTICLE 3: MEMBERSHIP Section 1: Membership is open to all individuals. Section 2: Each paid-up member is entitled to one vote, encouraged to hold office and participate on committees. Section 3: Ocean Wave Quilters, Inc. welcomes visitors to two meetings after which they are expected to join the club or pay \$5 to attend each subsequent meeting.

ARTICLE 4: ANNUAL MEMBERSHIP DUES Section 1: Dues are to be paid each year on or before the July meeting. Section 2: Dues received after August 1 shall be assessed a late fee; amount to be determined by the Board. Section 3: First-Time members joining after December 31 will pay $\frac{1}{2}$ of yearly dues for the remainder of that year.

ARTICLE 5: BUSINESS YEAR AND MEETINGS Section 1: The general meetings shall be held the second Sunday of every month. Section 2: The fiscal year shall run from July 1 to June 30. Section 3: All meetings shall be run in a constructive and courteous manner. Section 4: A board meeting that is open to all members shall be held monthly.

ARTICLE 6: VOTING Section 1: Robert's Rules of Order will be used as a guide when needed. Section 2: The quorum for a general meeting shall be a minimum of 15 members. Simple majority of 51% (minimum of 8) required for a vote to pass. Section 3: Any money decision being made outside of the approved budget that will cost the club more than \$50, unless the decision is time sensitive, shall proceed within one month as follows: A. The item will be

presented at a general meeting. B. The item will be published in the following newsletter, where members will be notified of an upcoming vote on the item at the following general meeting. C.

The item will be voted on at the following general meeting. D. Decisions on time-sensitive expenditures shall be made by the Treasurer and President (or, in the President's absence, the Vice-President).

ARTICLE 7: BOARD Section 1: The Board shall consist of a minimum of five members and a maximum of nine. Section 2: The Board shall include: President, Vice-President, Treasurer, Secretary, and chairs of standing committees. Section 3: Duties to be determined by the Board. Section 4: Board selection will proceed as follows: A. At the May general meeting, and in the May Newsletter, it shall be announced that all members interested in joining the Board shall attend the June Board meeting or submit a notice of interest to any existing board member.

Members shall also be reminded that voting for any office sought after by more than one member, if necessary, will take place at the June General Meeting. B. Immediately following the regular June Board Meeting Agenda, the new Board will be created by and from those present.

Those interested shall be generously willing to take over any needed tasks. If more than one person wants to hold a certain office, a vote for that office will be held at the June general meeting. The Vice-President can assume the Office of President after the V-P year if they want.

C. At the June general meeting, the new Board of Officers shall be presented, questions and/or concerns will be discussed, and any voting will take place, if necessary. Section 5: The Outgoing Board members and Incoming Board members will all attend the July board meeting. There the Outgoing Board and Committee Chairs shall turn over all books, files and data of the Ocean

Wave Quilters, Inc. to their successors. The Outgoing Board shall present any Bylaw amendments for discussion, and the Incoming Board shall take them to the July General Meeting

for membership approval. Section 6: The new Board will begin their duties at the July Board meeting and at the July General meeting. At the July Board meeting a Calendar for the new year will be set. In the August Newsletter, the new Calendar and updated Membership Roster will be

published. Section 7: Board Members shall serve the term of one year, except treasurer, who shall serve the term of 2½ years, overlapping a minimum of six months with outgoing & then incoming treasurer. Section 8: All Board Members shall be active on a club committee.

ARTICLE 8: OFFICERS AND THEIR DUTIES PRESIDENT: Shall preside at all meetings, lead the appointment of committee chairpersons, and help treasurer plan a proposed budget within first month of office. Provide agenda for every meeting. Set Calendar of Activities at July Board Meeting. Perform all other incidental duties of the office as required. VICE-PRESIDENT:

Shall assist the President and exercise all functions of the President in her absence. Perform all other incidental duties of the office as required. TREASURER: Shall have charge of all funds, receive dues, and disburse monies upon authorization of the executive committees and report all transactions upon the ledger. Treasurer and one board member signature shall be required on all checks. With help from President and approval by the board, plan a proposed budget which shall

be published in the May newsletter and voted on at the May General Meeting. Quarterly fiscal reports and annual budget shall be published in the newsletter and posted at general meetings as follows: July-September Report in October, October-December Report in January, January-

March Report in April, April-June Report in July. SECRETARY: Shall keep records of all general and board meetings. Shall keep a file on votes and amendments to the Bylaws. Perform all incidental duties of the office as required. ARTICLE

9: ONGOING COMMITTEES Committees will be designated as needed by the sitting Board at the start of each year. ARTICLE 10: AMENDMENTS TO BYLAWS Section 1: Outside the yearly review by Outgoing Board, Bylaw Amendments may be proposed by any member. Section 2: Amendments shall be voted on as follows: A. The item will be presented at a general meeting. B. The item will be published in the following newsletter, where members will be notified of an upcoming vote on the item at the following general meeting. C. The item will be voted on at the following meeting. ARTICLE 11: DISSOLUTION Section 1: In the event of the dissolution of the organization known as the Ocean Wave Quilters, Inc., all assets will be turned over to a non-profit, charitable, or educational organization to be selected by a majority of the Club Members at the time of such dissolution.
